This coverage can be added for \$330 per year or included in your budget payment for an additional \$30.00 per month. (Existing policies will automatically renew)

Customers choosing our **Service Protection Plan** will receive an additional .05¢ per gallon discount from the retail price of propane.

## Terms & Conditions

Gallons printed on the front of the contract are an estimate; feel free to adjust this number based upon your projected needs. Blue Flame also realizes weather can play a role in the number of gallons used, because of this we will give an additional 10% allowance on fixed price customers who need more gallons than reserved. These gallons would of course need to be paid for in addition to the original agreement.

To be eligible for these programs, you must agree to take delivery of at least of 250 gallons per year.

This agreement covers deliveries beginning July 1st, 2020, unless we have not received your agreement, in which case it will begin on the date we receive your signed agreement. The agreement covers deliveries made until June 30th, 2021, or until we have delivered all of your price protected gallons, whichever comes first. All subsequent deliveries will be made on an automatic delivery basis and be priced at our regular posted price. If at the end of the program year we have not delivered all of your price protected gallons, you may request a refund of any remaining credit balance. This is a dollar credit; unused gallons cannot be carried forward into a new program year.

Any and all balances due at the time of this agreement must be paid in order to qualify for these programs. Monthly budget payments are due the 10th of each month; beginning July 10th, 2020, and ending May 10th, 2021. Payments must remain current at all times; if you fail to make two (2) consecutive payments you may be discontinued from the program. Blue Flame reserves the right to re-calculate the monthly payment in the event you are using more gallons than the monthly payment will cover or if the price per gallon used for the discounted retail price budget is different from pricing at the time the payment was calculated.

Budget calculations for both programs are figured by taking the gallons printed on the contract, multiplied by the fixed price, including enrollment fee, then divided by 11 monthly payments. Although the discounted budget plan is not a fixed price we are using the fixed price to calculate a budget payment; as we do not know what the actual invoiced price per gallon will be at the time of delivery. Budget payments that are estimated too high would result in a credit balance on your account, which can be used for the future, or be refunded to the account holder.

Billable service, service policies, water heater lease payments, or other services will be invoiced separately if they are not already included in your monthly payment amount; these charges will appear as a debit to your account until payment is received.

Taxes and fees if applicable will be in addition to the program price per gallon and service policy cost.

If you have chosen a fixed price program, Blue Flame Gas Co. on your behalf will protect gallons purchased under this contract with forward physical futures contracts. For this reason there will be a \$1.00 per gallon fee charged on any unused gallons, if you terminate this agreement before 6/30/21.

The terms and conditions set forth in the Residential Propane Gas Service and Purchase agreement or Residential Customer Service Agreement and Credit Application signed by parties are hereby incorporated by reference into this Agreement. In the event of a conflict, the terms and conditions of this Agreement shall prevail.
